Retirement Bills Garner Backers: Several bills aimed at relieving two Social Security benefit reductions applying to certain federal retirees and survivors are gaining co-sponsors in Congress, although no legislative action has yet been scheduled on any of the measures, which have been introduced in Congress many times over the years. A House bill to soften the government pension offset, which reduces spousal or survivor Social Security benefits for those also receiving an annuity from a retirement program that doesn't include Social Security, such as CSRS, has 224 co-sponsors. Since that number is more than half the House, which effectively virtually guarantees the bill would pass if brought to a vote. Backers also crossed that critical number last year, however, and the measure never moved beyond a subcommittee hearing. A Senate counterpart bill (S-611) has 18 sponsors. Retirement 'Windfall' Provision also targeted a record number of co-sponsors, 149, has signed on to a bill (HR-1073) to ease the effect of the windfall elimination provision, which reduces the personal Social Security benefits of those with less than 30 years of substantial service in jobs covered by that system, again primarily affecting those who work under CSRS most of their careers. A bill to eliminate that penalty entirely (HR-848), meanwhile, has only 72 co-sponsors.

Here is a snapshot of the seven House and four Senate bills we are tracking: The seven House bills are: 1) H.R. 572, Off Budget, Rep. Michael Bilirakis (FL-9) has 64 cosponsors; 2) H.R. 664, **Government Pension Offset Reform**, Rep. Nancy Johnson (CT-6) has 65 cosponsors; 4) H.R. 848, Windfall Elimination Provision Repeal, Rep. Max Sandlin (TX-1) has 87 cosponsors; 5) H.R. 1073, Windfall Elimination Provision Modification, Rep. Barney Frank (MA-4) has 162 cosponsors; 6) H.R. 1177, Limit Medicare Late Enrollment Penalty, Rep. Frank has 33 cosponsors; and 7) H.R. 1307, FEHBP Premium Share Change, Rep. Steny Hoyer (MD-5) has 39 cosponsors.

The four Senate bills are: 1) S. 155, Equity for Dual Status National Guard Technicians, Sen. Jeff Bingaman (NM) has 8 cosponsors; 2) S. 561, FEHBP Premium Conversion, Sen. Collins (ME) is not seeking cosponsors; 3) S. 611, **Government Pension Offset Reform**, Sen. Barbara Mikulski (MD) has 18 cosponsors, <a href="http://thomas.loc.gov/cgi-bin/bdquery/z?d107:S000611:@@@N">http://thomas.loc.gov/cgi-bin/bdquery/z?d107:S000611:@@@N</a>; and 4) S. 627, LTC Insurance Premium Tax Deduction, Sen. Charles Grassley (IA) has 8 cosponsors.

LTC: The federal government's long-term care insurance program won't be available until late 2002, at the earliest. Furthermore, when it becomes available, you'll have to make many choices, each of which can make the difference between complete or incomplete coverage, between premiums you may or may not be able to afford. In fact, you may decide not to buy this long-term care insurance at all, or to buy it from another source, but you must be educated on this highly important life-affecting issue. These decisions certainly won't be easy, yet they might make a tremendous difference to you and your loved ones.

FedWEEK just published a BRAND NEW HANDBOOK, "The Long-Term Care Insurance Handbook for Federal Employees, Military Personnel & Their Families."
